**WHAT AN HONOR** that God has chosen me, just an ordinary person, to be His ambassador with OAC on the streets of Boston these past 12 years. It has been such a privilege witnessing and proclaiming God's Good News to adults and children from all over the world and do it from right here in the city as they come to our shores! I have loved training God-fearing adults and teenagers how to share the gospel in the classroom as well as out on the streets.

WHEN A CHRISTIAN IS WHERE GOD WANTS THEM TO BE and is obedient to render service, as to the Lord, that is the <u>safest</u>, most <u>challenging</u>, <u>productive</u> and <u>rewarding</u> place to be. I pray that's where YOU are today! I will truly miss the daily contact with godly evangelists and exhilarating adventures which God gave to us on a daily basis. For example, one day shortly after one of my co-workers had just finished preaching the gospel, we all had one-on-one conversations with folks. An outspoken male tourist from France walked by our sketchboard with his mom and loudly scoffed, "What a waste of time!" Even though I was in the middle of a conversation, I heard the scoffer and retorted very loudly and happily, "ARE YOU KIDDING? I HAVE THE BEST JOB IN THE WORLD!" The man and his mother just kept walking. About 10 minutes went by when the man returned. He said to me, "I am curious, <u>what</u> is the best job in the world?" I told him I was working for the Lord Jesus Christ and how God tells us in the Bible that there is only ONE way to Heaven. I am going to miss our daily encounters like this.

GOD HAS BEEN TEACHING ME that He wants me to praise Him and thank Him in all things...and truly mean it...even with daily debilitating pain and weakness. Because of the disabling pain and weakness, my normal routine has come to a standstill. Have you ever thanked and praised God in the middle of suffering for that very suffering? I am grateful that God, Himself, is teaching me this right now. I know that God is not through with me yet because I have His promise, "For I am confident of this very thing, that He who began a good work in you will perfect it until the day of Christ Jesus."

**AS I AM WRITING THIS LETTER,** I am preparing for our weekly children's Bible Club, held just down the street from me, in the housing projects. As long as God gives me enough strength, I will **continue** sharing Christ with these children and their mothers, as I have done these past 12 years. Please pray that God would grant these precious children and their families repentance and faith in Christ alone for salvation.

I THANK GOD for <u>each one of you</u> over these past 12 years. How can I ever thank you for praying for me and for lost souls to be saved? God answered your prayers. You prayed for divine appointments, and God gave them to us as only He could orchestrate. Some days God made me laugh right out loud! What a divinely terrific sense of humor our Creator and Redeemer has! How can I ever thank you for sacrificially supporting me and the ministry of Open Air Campaigners every month? Our OAC leadership has graciously made provision to continue issuing tax-deductible receipts to those indivdiuals who may still desire giving to my financial support account even in my "retirement" years. I am thankful for this provision (see enclosed letter from our OAC Board Chairman in this regard).

**GOD TELLS US** in Philippians 4:17, "Not that I seek the gift itself, but I seek for the profit which increases to **YOUR** account." God rewards not only the one who goes, but also the "sender." "I thank my God in all my remembrance of you, always offering prayer with joy in my every prayer for you all in view of your participation in the gospel from the first day until now."
